

## Fixing instruction door knocker ET1


## Mode d'emploi pour heurtoir



1.) Bohren Sie im Abstand von 70mm mit Ø 12mm ca. 20 mm tief in das Türblatt. Hierbei ist zu beachten, dass rechtwinklig zum Türblatt gebohrt wird.


- 1.) Drill with a distance of 70mm (2 ¾") two holes with ø 12 mm (1/2") and with a depth of approximately 20mm (13/16"). Pay attention that you drill right-angled to the door leaf.

  1.) Percez env. 20mm
- (profondeur) avec un entraxe de 70mm dans la porte avec un diamètre de 12mm. Veuillez observer que le perçage est fait à angle droit.



2.) Drehen Sie mit einem Inbusschlüssel SW8 die Muffe bündig in das Türblatt ein.

- 2.) Screw with an allen key (SW8) the inside outside threaded screw into the door until it is flat with the surface.
- 2.) Tournez l'écrou à visser planement dans la porte avec une clé à six pans (SW8).




Befestigen Sie den

3.) Fix the door knocker on the door by turning screw in the insideoutside threaded screw with an allen key SW5.

3.) Fixez l' heurtoir avec une vis dans l'ecrou à visser à l'aide d'une clé à six pans (SW5)

# Alternative for UK-Market: Visible bolt-through fixing



1.) Door Knocker can also be mounted bolt-through. Drill in with a distance of 130mm two holes with Ø 5,5 mm through the door Pay attention that you drill right-angled to the door leaf.
